The Multi-Discipline Alliance

Meanwhile, of those who went to a non-Alliance dentist, sixty-three percent (63%), reported that they contracted or suffered from a disease or ailment that they had not previously had, directly following their dental revision.

More recently, Dr. Huggins has found through clinical research and observation that root canals pose a serious threat to the patient’s health. In the same manner that it took years to bring the amalgam issue to the forefront, so is the struggle to inform the public of the dangers of root canal toxins. Again, the Alliance dentists are well educated and prepared to safely provide the necessary alternatives and corrective actions involved in dealing with root canals and cavitations.
